The same member of the public wished to state "they" did not agree with the Parish Councils summarisation of some football related literature. They went on to table two detailed questions regarding recreational usage/ lease agreement and essential maintenance of the recreational field. The member of the public also stated that Cambridgeshire Football Foundation had advised Mepal Sports not to enter dialogue with the Parish Council since their last correspondence some months ago. They also stated that whilst the Parish Council had previously advised that an independent charitable trust needed to be set up to bridge the gap between what a single football club can afford and the actual cost to the parish of maintaining and running facilities to play competitive sports, their stated view was that the Parish Council were responsible for the failure of the previous trust (Mepal sports action group, MeSsAGe). LW asked the member of the public to write into the council with their questions and the council would respond accordingly.
