### **CO-OPTION OF PARISH COUNCILLORS (CASUAL VACANCIES)**

### 1. Eligibility of Candidates

The Parish Council is able to consider any person to fill a vacancy provided that:

- He/she is 18 or over; and
- He/she is a British citizen, a qualifying Commonwealth citizen or a citizen of any other member state of the European Union.

and at least one of the following apply:

- He/she is an elector for the Parish and continues to be an elector; or
- Has resided in the Parish for the past twelve months or rented/tenanted land in the Parish; or
- Has had his/her principal or only work in the Parish for the past twelve months; or
- Has lived within three miles of the Parish for the past twelve months.

There are certain disqualifications for being a Parish Councillor (see Sch.80 of the Local Government Act 1972) of which the main are:

- Holding a paid office or employment under the Parish Council.
- Bankruptcy.
- Having been sentenced to a term of imprisonment (whether suspended or not) of not less than three months, without the option of a fine during the preceding five years; or being disgualified under any enactment relating to corrupt or illegal electoral practices.

#### **2. Applications** Candidates are required to:

- Submit information about themselves, by way of completing the short application form (pages 4 and 5)
- Confirm their eligibility for the position of Parish Councillor within the statutory rules (page 3)

Following receipt of application form(s) and confirmation(s) of eligibility, the next suitable Parish Council meeting will have an agenda item "To receive written application(s) for the office of Parish Councillor and to co-opt a candidate to fill the existing vacancy". Eligible candidates will be invited to attend the meeting.

Copies of the eligible candidates' application form(s) will be circulated to all Parish Councillors by the Clerk (or Chairman in the absence of the Clerk) at least 3 clear days prior to the meeting of the full Parish Council at which the co-option will be considered. All such documents will be treated by the Clerk/Chairman and all Parish Councillors as strictly private and confidential. A copy of the Co-option Eligibility form (page 3) and Application form (pages 4 & 5) are attached.

#### 3. Co-option Process

Mepal Parish Council invites interested candidates to apply to be co-opted onto the Council by completing the attached Application and Eligibility forms. The forms are circulated to Councillors ahead of the meeting at which a Parish Councillor is to be co-opted. These forms will form part of the meeting pack which Councillors receive for every Parish Council meeting.

At the Parish Council meeting candidates are invited to say something about themselves and Councillors have the opportunity to ask questions of the candidates. Each candidate will be allocated a maximum of three minutes.

As soon as all candidates have finished giving their submissions, the Parish Council will proceed to a vote with each candidate being proposed and seconded by the Councillors in attendance and a vote by a show of hands (Local Government Act 1972 Sch.12 Para 13).

In order for a candidate to be co-opted to the Parish Council, it will be necessary for them to obtain an absolute majority of votes cast (50% + 1 of the votes available at the meeting). If there are more than two candidates and there is no candidate with an overall majority in the first round of voting the candidate with the least number of votes will drop out of the process.

Further rounds of voting will then take place with the process repeated until a candidate has an absolute majority. At this stage, the successful candidate will be declared co-opted and will be asked to join the meeting.

A candidate who is co-opted will sign at the meeting a Declaration of Acceptance of Office, including an undertaking to abide by the Parish Council's Code of Conduct, and may take office immediately thereafter.

The Clerk will notify East Cambridgeshire District Council Electoral Services Office of the co-option of the new Parish Councillor.

A co-opted Parish Councillor will also complete a Notification of Disclosable Pecuniary and Other Interests form which the Clerk/Chairman will lodge with the Monitoring Officer at East Cambridgeshire Council within 28 days of the co-option.

The successful candidate is a councillor in their own right and is no different to any other member; co-option is a legitimate form of election as part of the election process.

Is employed by an entity controlled by the Parish Council; c. Is the subject of a bankruptcy restrictions order or an interim bankruptcy restrictions order or an interim bankruptcy restrictions order or a debt relief restrictions order or an interim debt relief restrictions order; or d. Has within five years before the day of co-option, or since his/her co-option, been convicted in the UK, Channel Islands or Isle of Man of any offence and has been sentenced to imprisonment (whether suspended or not) for not less than three months without the option of a fine; or e. Is otherwise disqualified under Part III of the Representation of People Act 1983 (relating to corrupt or illegal electoral practices and offences relating to donations) or the Audit Commission Act 1998.
