### 181223/1 CHAIRMANS WELCOME

## 181223/2 TO RECORD APOLOGIES FOR ABSENCE

Councillor Lorna Dupree had set apologies - work commitments.

### 181223/3 MEMBERS' DECLARATIONS OF INTEREST

There were no declarations made.

### 181223/4 TO RECEIVE DISTRICT AND COUNTY COUNCILLOR REPORTS

Reports from both the County and District Councillors had been received and are available on the Parish Council website.

Councillor Williams asked MI about a couple of topics in the report: Sutton Fire Station, the Doctors surgery, and the breaking news about Sutton Post Office. MI said that it was a concern, but the issues are different. In the case of the surgery, the issues relate to difficulties in negotiation for the use of the premises which are owned by an absent former GP partner, and it was simpler for the group to simply give notice for the Sutton practice which was on a separate contract to their other two surgeries. There have been difficulties looking for a suitable new premises, and the Heath Trust is re-examining the possibility of work to the existing building. MI felt that a sustainable solution will be found, eventually. In the case of the post office, it seems that One Stop no longer want to host, but the PO don't want it to close. Finding an alternative home for it is also difficult. MI said that we had to wait for the formal notice before any public action to try to stop the closure can be taken.

For the fire station, the reasons for the proposed closure relate to the number of call outs and the difficulty finding volunteer fire-fighters to man the station. Work patterns have changed and meeting the required times to be able to get to the fire station as people are working further away from their homes is difficult. There is talk of expanding at Ely, but it is not clear (with the proposed closure also of Manea) how this will work. Again, we await the final decision.

LW finally raised the issue of fly tipping and littering in the village and asked MI if he was aware of any ideas or initiatives Mepal could look at. The topic of a bin at the Engine Bank car park was also raised, and MI suggested that we contact EC Street Scene to discuss. MI wasn't aware of any specific recommendations that either ECDC or CC might be running, but again suggested that EC Street Scene may be able to advise.
