110324/6 OPEN FORUM FOR PUBLIC PARTICIPATION (max 15 minutes)

A question shall not require a response at the meeting nor start a debate on the question. The chairman of the meeting may direct that a written or oral response be given. A person shall raise his hand when requesting to speak and stand when speaking (except when a person has a disability or is likely to suffer discomfort). The chairman of the meeting may at any time permit a person to be seated when speaking A person who speaks at a meeting shall direct his comments to the chairman of the meeting. At the close of this item, members of the public will no longer be permitted to address the Council unless invited to do so by the Chairman.

110324/7 COUNCIL BUSINESS

a) To discuss boundary enquiry/works at rear of 17 Laurel Close bordering Mepal Allotments The Parish Council discussed the plans provided by Councillor Hickman and it was **RESOLVED** that a solid fence between 17 Laurel Close and Mepal Allotments/Play Area will remain with no gate accessing the allotments. As 17 Laurel Close has indicated they wish to have a gate opening onto the rear access path boarding 15 Laurel Close, as this is not land owned by the Parish Council, the Parish Council feel unable to comment on the effect or willingness of neighbouring properties to this proposal and suggest 17 Laurel Close make contact directly with their neighbours to resolve access. 17 Laurel Close will also be instructed to advise the Council when their panel is removed so remedial work can take place to re-instate the fencing.

b) To thank volunteers

The Parish Council wished to pass on their thanks to the almost 40 volunteers who attended the Pride of Place tree and hedge planting morning on 3rd March 2024. The event was a massive success and something the community will benefit from in the years to come and can be proud of. Special thanks go to volunteer Fiona Wynn for her dedication and hard work on this project.

A further 180 snowdrop plants were planted the following weekend and further daffodil planting in this area is scheduled in the next few weeks. Volunteers are also thanked for the tree guard removal at Lilibet Woods.

c) To ratify works to Mepal Footpath 10: The Rushway

The Council has been contacted by the Rights of Way Officer concerning significant damage caused to the surface of the Rushway through illegal vehicle use.

The proposal was to provide gate access at the Witcham Road entrance only. The gate will have a 1.52m wide gap alongside it to allow access for pedestrians and horse riders.

As with Byways subject to Seasonal Traffic Regulation Orders, any landowners who use this for access will be issued with a key to the gate.

Council RESOLVED unanimously to approve the works being carried out by County Council.
